CL20509 & CL20512 requires (3x) GR20400 3-4 Module Mounting Yokes. These plates are designed to be used with specified back box WA518 when flush mounting is required. 40mm back box supplied.

CL20518 requires (3x) GR20600 6 Module Mounting Yokes. These plates are designed to be used with specified back box WA20518 when flush mounting is required. 56mm back box supplied.

CL20524 requires (4x) GR20600 6 Module Mounting Yokes. These plates are designed to be used with specified back box WA20524 when flush mounting is required. 56mm back box supplied.
