## Wiring Each coaxial cable should be connected to the appropriate terminal as shown. This diagram applies to all unscreened non-isolated and isolated connections including diplex (TVFM) units. Care should be taken to ensure that the screening braid is clamped securely by the cable clamp and does not come into contact with the centre conductor.
